NAME OF ANIMAL: All animals **must** have a prefix in front of the name, either your own or the breeder's. Use your prefix in the exact same form each time. Do not use "quotes" in the name. Recommended that all prefixes be 12 characters or less. ENTIRE NAME INCLUDING PREFIX punctuation and spaces MAY NOT exceed 30 (*) total spaces. Too-long or offensive names will be shortened, rejected, or places in the Hold File.

In accordance with ADMS rules, name changes must have written permission from the First Person to register the animal (original owner), be under the age of two years (24 months), have no show recorded or recorded offspring. Breeding Certificate:

Required for animal to be included in MDR and for sire to appear on pedigree, regardless of age of animal being registered.

You must be a current member of the Am Donkey & Mule Society in order to register an animal. (If you are receiving your BRAYER magazine your dues should be current). If not, please send your membership fee of \$34.00 US (\$43 Canada or \$55 overseas) for your membership in addition to the animal's registration fee. Send with two (2) photos, one of each side, size noted above. (Photos are REQUIRED.) Reg fee for a jack or jennet is \$17 each. **IF THE BREEDER** wishes to register an animal directly to the new owner, breeder should list themselves as the breeder and new owner in the owner area. No additional transfer fees or forms required. If the BREEDER wishes to be listed as the first owner and THEN transfer to a new owner, the additional \$5.00 transfer fee and form are required. **DO THIS** if you wish to make sure no future name changes are allowed. **If you photocopy this form, PLEASE be sure to copy the back (rules) as well for new members.**

APPLICATION FOR REGISTRATION into "THE MINIATURE DONKEY REGISTRY "

REGISTRATION RULES (please read carefully and completely)

INSPECTION: Jacks and Jennets which are not out of registered parents will be placed in ADR (rule effective as of Jan 2009). Inspection other than bite and testicles on males 24+ months is not required when BOTH parents are registered MDR. (If parents are not both Miniature Mediterranean, this is not the correct form.) Geldings do not need to be inspected. **However, ANIMALS SHOWING EXTREME Disproportional CHARACTERICS MAY BE REFUSED.** Consultations will be done on these cases.

- HEIGHT.** Miniature donkeys are defined as members of the breed by height. The miniature donkey must be 36" or under when mature. Animals over age 3 must be accurately measured and height given on the form. (The owner is responsible for this, it does not have to be done by an inspector.) **Measure accurately from ground to highest point of the withers. We will not list increments of less than 1/8th inch.**
- PHYSICAL IDENTIFICATION.** Some form of permanent physical identification is **REQUIRED** by this registry. Lip or ear tattoos, brands, ear tags, electronic identification (microchips) may be used. Put any tattoos etc. under "description" on registry application. IF NO ID the donkey must go in ADR.
- TRANSFERS** of ownership are accomplished by means of a form available from the registry. Follow directions on form. Original Certificate must accompany any transfer papers. \$10.00 Transfer fee for Immature, \$8.00 for mature animals. ' This form is not for transfer only of registered animals.
-  **TO REGISTER A DONKEY, THE OWNER MUST BE A MEMBER OF THE AMERICAN DONKEY AND MULE SOCIETY.** This fee is \$35 for the current year (US members, \$45 Canada/\$55 overseas) and you will receive THE BRAYER MAGAZINE and our other services.
- Fill out this application as completely as possible. If the animal's parents are not registered, this is not the correct application, the animal will be placed in our ADJR Book instead of the MDR. We will not accept an actual birthdate for animals where the breeder and dam are both unknown. If a birthdate is given, we require at least a name/color and owner for the dam (mother) to be shown on the application.
- REGISTRATION FEES:** (You must be a paid up member to register an animal-see #4 above) **Registration of any jennet or jack 20** under age 36 months, \$30 over age 36 months Registration of a gelding \$8.00 * Certificate/application Corrections \$10.00 (Mistake on application)
- PHOTOS & IDENTIFICATION ON THE REGISTRATION APPLICATION.** Please fill out the portion which asks for description by describing any markings which do not appear in the photos, such as "collar buttons", stars on forehead, garters (leg stripes) or other markings which may be useful for ID purposes . **ONE PHOTO OF EACH SIDE IS REQUIRED** (2 total photos). They must show color of animal & shape of Shoulder stripe. **PLEASE SEND CLEAR PHOTOS !**
- The first person to register the animal may choose the animals name.** If the breeder wishes the animal to be named My Farm Bubba and not His Ranch Buddy, the BREEDER must be the first person to be listed as owner. If you send only this application with an animal at the time of sale, the new owner (or whomever after that sends the application in to ADMS) may use their own prefix on the application and does NOT have to use yours. See instructions on the front at the bottom edge of this form. If you are the BREEDER and want the animal to show YOU as the BREEDER and FIRST OWNER, then sold to another person, fill out both as BREEDER and OWNER and include a transfer form. Include \$20. Otherwise, we will list you as BREEDER and register the animal directly to the new person (\$23). Third-party prefix fees will be charged if the prefix rules are not followed correctly.

TO REGISTER AN ANIMAL SEND THE FOLLOWING ITEMS -

- A filled out registration application. (the other side of this form) If information is not known leave blank. Fill in everything that can be told from looking at and measuring the animal. (Be sure the name you select has a prefix: see below)
- If BOTH of animal's parents are not registered note that after Jan 2009 these donkeys will be placed in the ADR reg bk.
- Two photos of animal. One of each side. Side views only. Be sure that the shoulder stripe shows clearly if animal's color allows it to be seen.
- Registration fee.** Jack or jennet \$20.00. Donkey gelding \$8.00.
If you are not a **currently paid member** of the American Donkey and Mule Society **send the correct membership fee.** (you will receive access online to THE BRAYER MAGAZINE services with your membership)

- If parents of the animal are not registered with ADMS, and you have pedigree information, please send it on a separate sheet, or send copy of other registration certificate if animal is registered with another registry. **Animals may be registered with no pedigree. If you do not have the certificate but know the registration number in another registry note under "description"**
- A certificate of service (breeding certificate) must accompany the registration of any animal which is sired by a registered jack, regardless of the age of animal being registered (whether it is adult or foal) Otherwise sire will be listed only as "unverified" and may be placed in the ADJR book instead of MDR. Certificates are available from registry office. (Change of Certificate from "unverified" to Jack will be a fee of \$7.00). If the breeder and exact birthdate of an animal are known, some form of parent identification must be given. We are unable to register an animal with Joe Smith as the Breeder but parent information listed as "unknown".

CHECKLIST - Before you mail: Make sure you are sending:

- This application. Did you keep a photocopy for yourself?
- Inspection form if needed -and did you check the BITE on the animal? It's required!
- TWO photos - one of each side (one left, one right)
- Registration fees.
- Are you current with ADMS?
- Additional pedigree info if applicable, and stud report for current year filed.
- The breeding certificate.
- Did you make sure the NAME is under 30 characters TOTAL?

PREFIXES When you register your first animal for which you choose the name, please choose a registry prefix to be permanently assigned to all of your registered animal's names. Choices are often initials, farm names or last names. This will be used to identify all of your registered animals. Please use it in the same form every time. If your prefix is ABC, do not write it A.B.C. (Using this as an example your animals would be ABC Baby, ABC Star, ABC Bubba, ABC Little Bit, etc). Nobody else will be allowed to use your designated prefix. In this way, you may choose a name you prefer for your animal without worrying about whether it has been used before. *We do not duplicate prefixes. If you request prefix already in use, your paperwork will be held until we can contact you* **There is a 30-character limit on the length of name,** and we ask that you try to restrict to 12 characters for new prefixes. prefixes. Because we have over 60,000 registered animals, we will not register a donkey without a proper prefix. The prefix may only be your own, or that of the breeder of the animal. If a third party is involved, charges for corrections to paperwork to fit the prefix rules will apply. Applications sent in with NO PREFIX listed on the form will be held until the prefix can be provided. If in doubt or you have questions, PLEASE CALL BEFORE SENDING YOUR PAPERWORK IN if you have questions! . REV 2-16-24
